- Perform pool chemical checks at designated times.
- Keep accurate records of pool usage, chemical levels, pool closures, etc.
- Attend and participate in all Mandatory Staff Meetings and Trainings.
- Hold productive and engaging 30 minute lessons.
- Complete our Bubbles and Mastering Form Training. Teach all group lessons based on this format.
- Set up and clean up lesson station.
- Keep accurate and timely records of all lessons taught, purchased, scheduled.
- Maintain open communication with client and/or client's family about the progression of the lessons

and future goals.

- While working as a Group Lesson Instructor and/or Lifeguard, follow the Coordinator's and Aquatics Directors directions and requests.
