CONDITIONS OF MEMBERSHIP

2. All adult members of the Tuggeranong Valley Women's Bowling Club must provide proof of current membership of the Tuggeranong Valley Rugby Union and Amateur Sports Club upon request.
3. At least one parent of a Junior Member of the Tuggeranong Valley Women's Bowling Club must provide proof of current membership of the Tuggeranong Valley Rugby Union and Amateur Sports upon request.
4. Social Members are not eligible to play bowls, Association Matches or Club Championships, nor are they entitled to vote at any meeting or to be elected to any office of the club.
5. Members must agree to abide by the rules set out in the Tuggeranong Valley Women's Bowling Club Inc. Constitution and By-Laws and the Tuggeranong Valley Women's Bowling Club Code of Conduct.
