GLOSSARY OF TERMS

AAI	Archery Australia Incorporated
Anniversary Date	The annual date for payment of membership fees
Associate Member	A non shooting member of AAI, such member has no rights and privileges but may hold club positions.
Family Membership	A discounted membership rate offered to families
Individual Affiliate	Also referred to as an Individual Member
Minor	A person who has not achieved their 18 th birthday
RGB	Recognised Governing Body
Senior (adult)	A person aged 18 years and over.

OBJECTIVE

This document details the terms and conditions for Archery Australia Inc members

POLICY

An Individual affiliate's (herein referred to as Individual Member) annual membership fees are due in full on the annual anniversary date of joining Archery Australia Inc. The following terms and conditions apply to AAI individual members.

AAI CONSTITUTION, SHOOTING RULES, CODE OF CONDUCT AND ETHICS, POLICIES and PROCEDURES and BY-LAWS.

All individual members are bound by the AAI constitution, the code of conduct, ethics, professional conduct, rules, by-laws, notices and directives of AAI.

CONDITIONS OF MEMBERSHIP

AAI members are required to indicate on the membership form (or electronically), their acceptance of all terms and conditions of membership to AAI, their Club and RGB.

FAILURE TO PAY

AAI membership fees are due annually on the membership anniversary date plus. If an individual member does not pay their membership fees, they will cease to be an AAI individual member after 14 days of the anniversary date shall lose all rights and entitlements.

If fees remain unpaid 30 days after the anniversary date they shall be removed from the AAI active member database.

RE-JOINING AFTER BEING REMOVED FROM ACTIVE MEMBERSHIP DATABASE.

Irrespective of when the individual renewing member pays their fees, all fees shall be backdated to their annual anniversary date.

If an individual members re-joins 12 months or greater after their anniversary date the new joining date will become their future anniversary date.

SENIOR (Adult)

A person aged 18 years and over and will include age divisions, 20 and Under, Open, Master and Veteran.

MINOR

Minors (under 18 years of age) will receive a discounted membership fee.

Minors who have not achieved their 18th birthday at the time of paying their annual subscriptions the Minor membership fee rate applies.

If the person is 18th years of age and over at the time of joining or re-joining the adult membership fee rate applies.

FAMILY MEMBERSHIP

AAI offer discounted membership fee for families. Conditions of this Family Membership shall be

- 1) All 'families' must fall under one of the legally accepted forms of a family.
- 2) There will be 2 levels of Family membership
 - a. Family 1 – Two Adults and One Minor
 - b. Family 2 – One Adult and Two Minors
 - c. Each additional minor will pay an Additional Family Member fee.

ASSOCIATE MEMBER

AAI offers Associate Membership to individuals who are social members such as family members or retired members who do not intend to shoot but are willing to volunteer and be part of the sport and local activities.

REFUND POLICY

AAI does not provide refunds on membership fees except in the case of death which occurs within 3 months of payment date of such fees providing fees were paid by the due date. Such fees will be refunded on a pro-rata basis less a \$10.00 administration fee following receipt of an official written request for a refund.

TRANSFER OF MEMBERSHIP

AAI does not allow for the transfer of membership to any other organisation.

COSTS INCURRED IN PROCESSING MEMBERSHIP FEES

There are no fees imposed for the processing of membership fees except for unexpected costs incurred by AAI in the processing of membership fees which will be charged back to the individual member or Regional Division.

Such costs include, but are not limited to, all dishonour payments and related bank charges.

GST

All membership fees payable to AAI are inclusive of GST.
