4. Business Arising:

 - Green Card 2 minutes
 - Breaking on Penalty Corners (attacking and defending players to go behind half way line)
 - Free hit inside 23 mtrs to be taken at the point of the break no matter where but ball must still go 5 mtrs before the ball can enter the circle, positive communication to all the players at the point of free hit.
 - Position of the Corners now will be played at the point on the 23 mtrs line where the ball crossed the goal and back lines.
 - That all captains must wear arm bands.
- Motion: That the Shoalhaven Competition will not play the “sticks over the shoulder” rule.
