## Item 2 Field Hockey Competition for ISCH 2016

The following was discussed and will be presented at the next Joint IWHCC & SCHCC Meeting set for

Monday 29<sup>th</sup> June 2015 6.30 to 8pm Albion Park Bowling Club.

1. In the joint competition put Divisions 1 & 2 in sequence at both venues. This will allow clubs with Division 1 and Division 2 teams time to build
2. Divisions below Division 2 will be" venue based" This means Divisions 3 and 4 play at home.

3. With Clubs with only one team either in Division 1 or Division 2, each competition committee can invite teams in to fill the gaps.
4. No Division 2 games to be played on turf 2 at Croome Road.

### **Item 3 Other Final Series Matters**

For Semi-finals - a player named in a team, can play in the semi-finals if they have played 40% of the rounds played IN THEIR TEAM'S DIVISION. (Generally 8 rounds)

A player that is regraded must play 5 rounds in the divisional team they have now been named in. For a regrade to get an exemption, it is usually a documented injury. Reminder players can play in all divisions that they are named in.

Representative players that have missed round games, take the number of games they have missed from the total round games (usually 21) and then calculate the 40%.

### **General Matters.**

1. Lock up ( Field left Sat 13<sup>th</sup> June 2015 Last Game -Division 3 Dapto v Uni incomplete lock up)

The club teams that have duty for the last game/s of a competition day must

Lock up the central building as well as everything else.

Where no duty has been appointed the duty to Lock Up goes to the Club first on the draw.

We have a wonderful sporting resource it surely is every hockey player's responsibility to take care of it.

Clubs are to check with Sue Abba who are their key holders. Keys are to be signed for. Key holders should avoid lending keys. If clubs can account for their key holders they can sign up for additional keys.

2. Reminder for Duty Teams.

Game 1 Duty is to collect the Umpire gear and the ice from the stadium before the game one.

The person in the office on Fridays are to prepare the eskies for Saturday games.

Last game duty is to return the umpire gear and the eskies to the stadium.

Each game slip is to be signed up and kept in the "black clipped folder" supplied in each dugout.

3. Rescheduled Games were discussed

Note the following

- Any requests to reschedule a game must go with at least 7 days' notice prior to the competition game, to Fixtures – Wesley Johnston.

Fixtures will set time/s for the reschedule and the clubs negotiate.

Fixtures have the final say when the game can be played.
