- Raise any problems with an official or coach through the appropriate channels;
- Accept and understand that not all players may execute a play in the same way or to the same standard;
- Support your Club by attending games and functions;

PARTICIPATION AGREEMENT:

I/We, the undersigned, in consideration of BWA-LLWA and Baseball Australia agreeing to register my child as a participant in sanctioned competition hereby:

- Undertake to be bound by the laws of the game of Little League baseball and the rules and regulations of BWA-Little League WA (LLWA) and Baseball Australia and to pay all requisite fees and subscriptions by the date specified by my club;
- Agree to be bound by any codes of conduct or policies as may be promulgated by BWA-LLWA and Baseball Australia from time to time and in particular agree to abide by published BWA-LLWA policies pertaining to Harassment Free Baseball, Anti-Vilification, Infectious Diseases and protocols relating to the serving and consumption of alcohol;
