**Hockey Queensland Indoor Player Registration 2018/19**

Hockey Queensland (HQ) has introduced a compulsory Indoor Player Registration Fee for Indoor players from the 1st September, 2014. This fee has been introduced to cover the administrative costs of Indoor Hockey (in relation to State Team Challenges, Trials, Events, State Teams, etc.) and includes an insurance component so all players, regardless whether they play outdoor or not, are covered. All players involved in Indoor competitions across Queensland will be required to complete an on-line registration on the IMG HQ Indoor database as per the outdoor registration process. Upon registration, players will be asked to pay the compulsory Indoor Player Registration Fee which is \$17 for senior players (this requires a credit card online). The direct link is:
