Registration Declarations

Registration declarations are the conditions that a member, either new or renewing, chooses to accept at the time of joining / renewing via the online system.

A club can have up to 3 declarations in place and these can be setup by the following.

Log into the Club.

Click “Members”

Click “Registration Declarations”

Click “Edit”

Once in place a member will have to tick that they accept these conditions prior to allowing them to complete their membership.

Below are some samples of what type of thing may be used. You can include multiple statements in the one declaration box if you wish.

Title:	Terms and Conditions	
	In this area Terms and Conditions that Members need to adhere to can be inserted. When set at the state level this will syndicate down to the club level.	
	Three declarations can be entered at this level. Further to this, a declaration that relates to Subscriptions can be entered in Subscription Types eg. Junior declaration.	
	A club might also have a set of declarations that relate direct to their club members - they can enter this in their database.	
	Declarations might include terms and conditions / refund policy / privacy policy / player conduct
