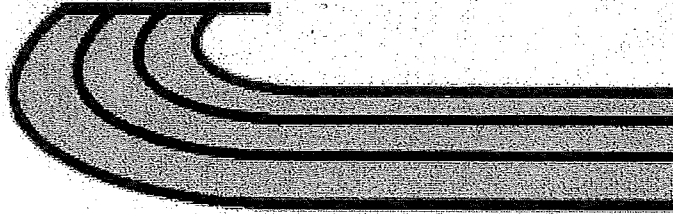

2016- 2017

It is with pleasure that I present, on behalf of the Board of Athletics South the 63rd Annual Report. Contained within you will find a record of the activities of the Branch for the 2016 -2017 season.

The 2016-2017 season has seen Athletics South continue to prosper due to the hard work and dedication of everyone involved in the organisation, from the Executive right through to the grass-root level.

Registrations have continued to grow strongly in Southern Tasmania largely due to the tireless efforts of all the clubs.

Our Track and Field Inter Club Premiership went right down to the wire, and congratulations to all clubs for providing great competition and congratulations to Eastern Suburbs in making a "clean sweep" in winning the Women's, Men's and Combined Premiership.

The Winter Cross Country program once again enjoyed outstanding success with increased numbers and a big thanks to Pete Keenan and his very hard working committee for their great effort and congratulations are extended to Northern Suburbs in winning both the Men's and Women's Premiership.

The Running Edge award was awarded to Francesca Smith with Ebony Webb and Meriem Daoui equal second.

The continued success of our home grown athletes on the national and World stage is an indication of the healthy state of athletics within our organisation

I would like to take this opportunity to thank all the coaches who have contributed to our amazing success this season.

Although I have noted all of the positives above, it is unfortunate that there appears to be some people within the athletic fraternity that have had great pleasure in expressing their concerns regarding the efforts undertaken by the Board of Athletics South.

For the knowledge of the above people and the general athletic community, Athletics South have in the past 18mth spent over one hundred thousand dollars (this is not including grants) for the purchasing of a new Photo Finish system, speakers, wind gauge and everything else that is associated with PF system. We have purchased a number of throwing implements, pole vault poles, contributed towards the cost of the new Hammer Cage and are currently in the process of acquiring a new Pole Vault bag and a full set of starting blocks.

In the past 5 years we have refurbished both upstairs and downstairs of the admin building with new carpets and blinds. Purchased 5 new computers and a photo copier.

AS has made provision in the new equipment shed for club lockers, to enable them to store equipment etc.

Purchased a defibrillator for the use at the DAC and Cross Country.

Purchased AS polo shirts free of charge for all officials and contributed half the cost of water proof jackets for officials.

I think some people think that AS has a money tree in the car park, but the reality is that the AS Board both past and present, has worked tirelessly to put AS into the healthy financial position that it enjoys today and which is the envy of many State and National bodies.

For people that are new to athletics and for the people that conveniently choose to “forget”, from 2002 until 2009 Athletics South in conjunction with Guides Tasmania and with the assistance of SBHC, OVA, ESAC, TMA and NS were the “Clean Team at the Taste of Tasmania. This involved working 4 days prior to Christmas Day, then 8 days following, working shifts which commenced at 7.00am and concluded at 12.30 am the following morning.

Monies from this fundraiser was distributed to all the clubs and AS placed their share of the money into the provision of new equipment.

The AS Board also has secured sponsorship from Optus (Tascall in its infancy) and also Bennett’s petroleum, and for the past 15 years has opened the canteen during school carnivals, which also provides funds for new equipment and maintenance thereof.

While we acknowledge that we are not perfect, and that there is always room for improvement, hopefully by providing this short snippet of information some people within the athletic fraternity may realise that the AS Board has not been sitting on their hands over the past 20+ years and that they will continue to seek sponsorship to provide the best possible competition and equipment to all our athletes.

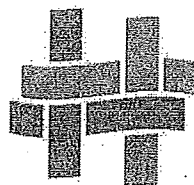

TRACK & FIELD REPORT

Programming the 2016-17 AS season was very difficult due to significant delays by Athletics Australia, and subsequently Athletics Tasmania, setting dates for key dates which impact our programming and venue availability. I thank all involved for their understanding in this, as it was out of the control of the AS Board, and hopefully will be smoother for the next season.

At the request of some athletes and Clubs, we also implemented some trials of changes to programmes and timings. Results for this trial were mixed, and hard to judge, so if re-elected, it is my intention to continue this trial into the next season, including consideration for evening competition. This has been made more achievable by the new photo finish system, however we still need people to be trained in key roles such as starter, to enable this as a realistic proposal. I am also at the time of writing, in discussions with Little Athletics Tasmania staff in relation to a smoother overlap and interaction, and the ongoing interaction with TMA should continue, with potential to expand; subject to further discussions.

An additional trial which has been discussed by the Board relates to the entry procedure, and will make entry much smoother for those who enter multiple events, and will make things smoother both for athletes and administration staff.

The two most positive points from this season were that 4 Clubs won individual rounds in the Male Premiership, which has not happened for a number of years, and also the increase in participation from para category athletes.

I have re-nominated for the role, and modifications from last year which have been discussed will see the large amount of opportunities for qualification and records through sanctioned meets be balanced by the opportunity for maximum participation for our athletes who aren't aiming at higher level, but just want opportunities to compete as many times in the sport.

I thank Clubs for their support, especially the understanding that with the number of athletes and philosophies within the sport, not everyone can get everything they want, and some flexibility is required by all involved if the sport is to move forward.

TECHNICAL & EQUIPMENT REPORT

This year has seen Athletics South begin the project of replacing the hammer cage, which continues into the 17 /18 season.

The major project last season being the upgrade of the hammer cage, which will be ready for the 2017-18 season thanks to the Tasmanian Community Fund. A special thanks must go to Hobart City Council, Utas Athletics club, University of Tasmania and Masters Athletics who have provided financial Support for the Hammer Cage. Also I would like to thank Evan Peacock, Stuart Morse and Nathan Morey for their time put into the application and project and also to the clubs and other entities that provided support.

During the season it was brought to the attention of the board that the Pole Vault Bag was fast approaching its used by date. So AS with the help of the pole vault Community have been seeking financial assistance to replace the bag and uprights for the being of the 17/18 season. In the meantime AS with the help of the pole vault folks have made repairs to the bag to last out the season.

AS also continued to upgrade and replace throwing and jumps equipment as needed throughout the season.

During the coming season we are looking to upgrade some of our permanent equipment e.g. Pole Vault, Hurdles and Steeple Chase Hurdles so if any companies or individuals wish to help with some sponsorship – either monetary or in-kind they can speak to Helen Lee or myself.

I, or the new Technical Manager, would like the help from all coaches and athletes in the off season and the upcoming competition season with the reporting of any damaged equipment and equipment that needs to be replaced.

WINTER COMPETITION REPORT

The 2016 Winter Season was once again an outstanding success, with increased numbers competing each week. The first race of the season was the annual Graeme Cruise Memorial at Bellerive Beach with 259 competing; the high numbers were to continue each week with weekly average of 170 competing over the season. The lowest number being 60 in the fun relay at Wentworth Park.

I would like to commend all members of our clubs for their strong support provided during the season. Clubs are rostered to assist in setting up courses each Saturday, all clubs have provided this support with athletes and their families arriving early each Saturday morning to assist in the preparation of the event and then competing and following the race going back out collecting the flags. Further to this clubs have actively pursued new members throughout the season; with I believe registrations reaching an all-time high. Athletes are also wearing club uniforms with their registration numbers on the front of the singlet. Each club now erects their club tents, this not only provides great atmosphere but also gives each club a focal point, runners now converge in their tent area and any new members have no trouble seeking out information from a club when they present asking to become a member

Each year we conduct races all over southern Tasmania, in doing so we do go to some private properties. For many years we have gone to Ian Smiths apple orchard at Grove and in recent years the McPherson property at Bagdad. Both courses have the reputation of being tough and challenging and are always well supported. I would like to thank both families for their continued support. St Virgil's College has also allowed us the use the college property and provided keys to the toilets; I would like to also thank the school for permitting the competition to be held at the venue.

This year a new course was introduced at Runnymede, this is again on a private property which is owned by a member of Fiona Lennon's family, the course was well received by all of those who competed and bought back memories of the cross country course that for many years was conducted at Broadmarsh.

Tasmania Police also support the winter season each year by effecting road closures at the Lower Domain Rd and Ridgeway. Although there is a cost associated with the road closures both races have long traditions and it would be unfortunate if the events could not be conducted. Spectran also assists by providing the signage and barriers for the road closures.

Unfortunately as it is becoming harder to secure venues to conduct events the competition has had to pay for venues again this year, events where venue costs are incurred are the Police Academy, Baskerville Raceway, Ridgeway, the Lower Domain Rd and Huntingfield.

As our numbers have increased the need has arisen to hire a dual portaloo from a commercial supplier. I would like to take this opportunity to thank Phil Hiniat and Bob Welding for their support by being available to pick up and return the portaloo,

very much appreciate your efforts by generously giving up your time to complete this task.

Athletics throughout Tasmania has grown considerably in the past twelve months, both at an AS level and from a recreational running perspective. The Parks Runs commenced in 2015, the runs are conducted each Saturday morning at 9.00am at Risdon Brook Dam. When this new event was first planned I was of the view that it may affect the numbers competing at Cross Country, this has not been the case with some runners competing in both events and new runners coming over from the Parks Runs and joining clubs.

Another new initiative in regard to running in Tasmania was the introduction of the Tasmanian Road Runners in January 2015, a similar model is available on the mainland, it effectively provides information about every fun run in Tasmania and encourages people to not only take part in the sport of athletics but encourages their members to join an athletic club. The club tent was also erected at the first race of the season, this gave TRR members a focal point to assemble and in turn be given information about the athletic clubs. I thank Jemina and Jay for their hard work in founding TRR and in doing so providing a new path way for people to join athletic clubs'

Unfortunately our season ended on a very sad note with the passing of Jenny Lennon. Jenny has been my offsider for over thirty years turning up each Saturday morning regardless of the weather accepting entries and recording results. I personally will miss her terribly as I am sure will the rest of the athletic community. Jenny's family have consented to a memorial race being conducted in her honor at Runnymede in 2017.

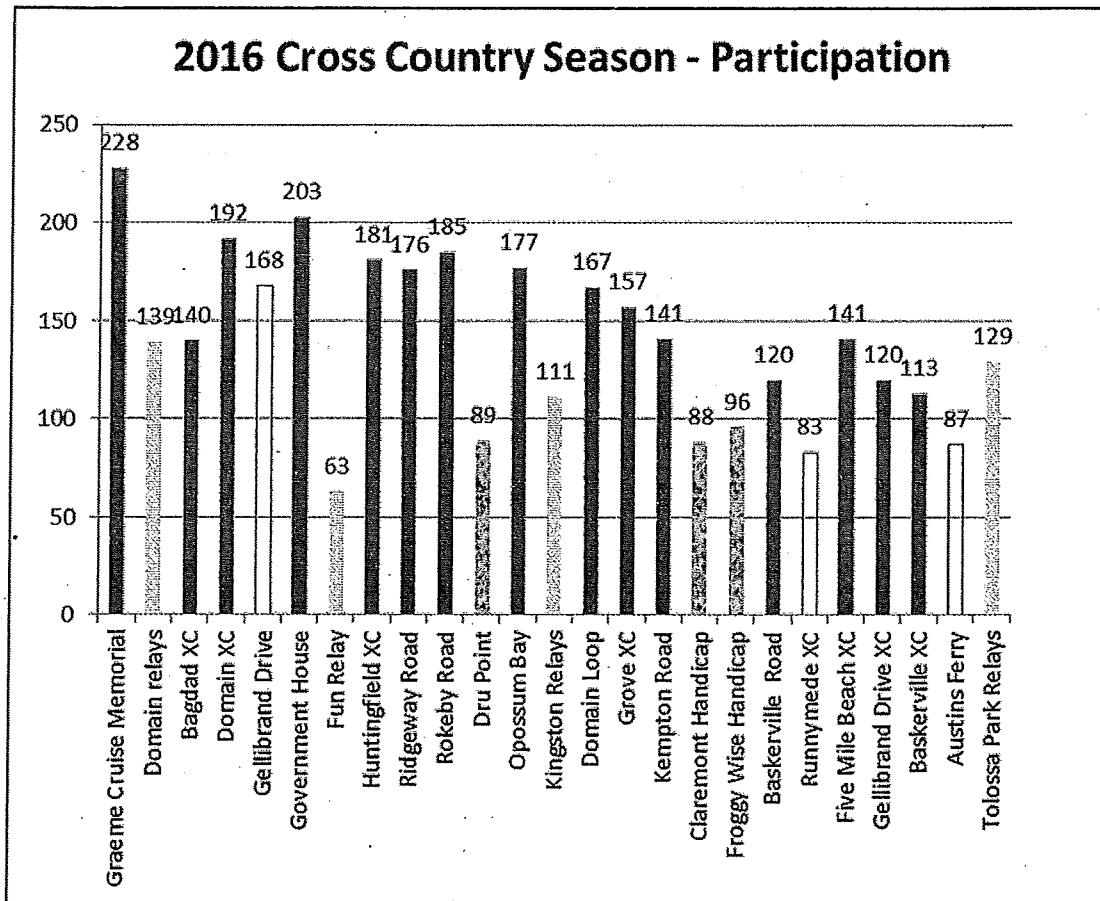
For the third time the Running Edge was the seasons sponsor, with the shop providing weekly spot prizes at cost price and orders on the store for the Athlete of the Season Award. General Comments in regard to participation

1. The participation levels followed the pattern of previous years – the strongest participation in the first half of the season with reduced fields in the second half. Participation in most events was down compared to the last two years. In particular, participation in the last few events was typically 40+ down the same events last year.
2. Compared to the two previous years, there was less participation in handicap events and relay events.
3. The Froggy Wise event, like the other handicap events attracted a comparatively small field compared to the inter club events

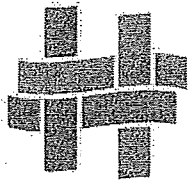
OFFICIAL'S/DEVELOPMENT REPORT

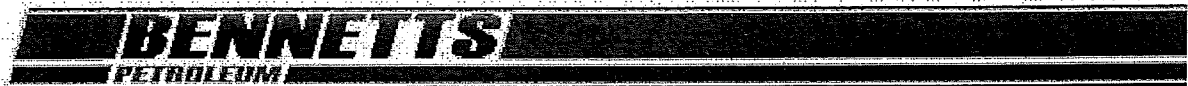
