#### TREASURER'S REPORT

I am pleased to report that our club made a surplus of \$1,025 for the financial year ended 31 March 2013 compared to a surplus of \$2,209 for the previous year. The slight decline in surplus was largely due to the write-off of merchandise due to slow sales. We also saw interest income decreased by \$242.

On the revenue side, membership subscription went up by \$1,760 with the increase of membership number from 328 in 2012 to 386 in 2013. Uniform sales surplus went up by \$626.

The increase in revenues was negated by the following increase in expenditures:-

- The write-off of 50 per cent of the stock of merchandise of polo shirts and v-neck shirts to the value of \$1,948. Due to the slow sales of these products, the committee decided to give them away to new members as a marketing strategy.
- The cost of general administration went up by \$280 mostly due to the hiring cost of venue for committee meetings.
- The AMA Championship expenses went up by \$356.
- The purchase of a 100lb Throw Weight and a 45lb Throw Weight at a total cost of \$850.
- The online administration fees paid to IMG went up by \$346 due to the increased usage of the online facilities for uniform shop and event entries.

In conclusion, the Club is in a healthy financial position with accumulated funds of \$36,840. The committee will continue to manage the funds responsibly for the benefit of our members. I want to renew our thanks to our sponsor, Mr John Plummer, for his continual and generous support of our Club. I would also like to thank Mr Gary Wong of Wong and Fergusson Chartered Accountants, for his role in auditing the Financial Statements.
